Dear Members of the Planning Board:

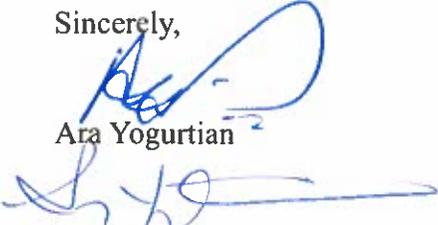
As you are aware, on or about August 23, 2023 we have submitted an Application for granting of two (2) Special Permits relating to proposed construction of an additional six hundred (600) square feet of space to the current two (2) family structure at 196-198 Beech Street ("Property").

Specifically, the Application for Special Permits seeks relief under Town of Belmont Zoning By-Law §1.5.4(A) (alterations beyond three hundred [300] square feet) and exceeding maximum lot coverage of 31.5% (proposed 32%).

Presently, the Application for Special Permits is scheduled to be heard before this Board on October 17, 2023. Given Ara Yogurtian's position with the Town as the Chief Enforcement Officer and work with the Planning Board, we will not make the presentation before the Board on October 17, 2023. The presentation will be made exclusively by Clifford Rober, LSP. Further, we have retained counsel, namely, Steven K. Parnagian, Esquire who will be present at the hearing and available to answer any questions the Board may have that are not addressed by Mr. Rober.

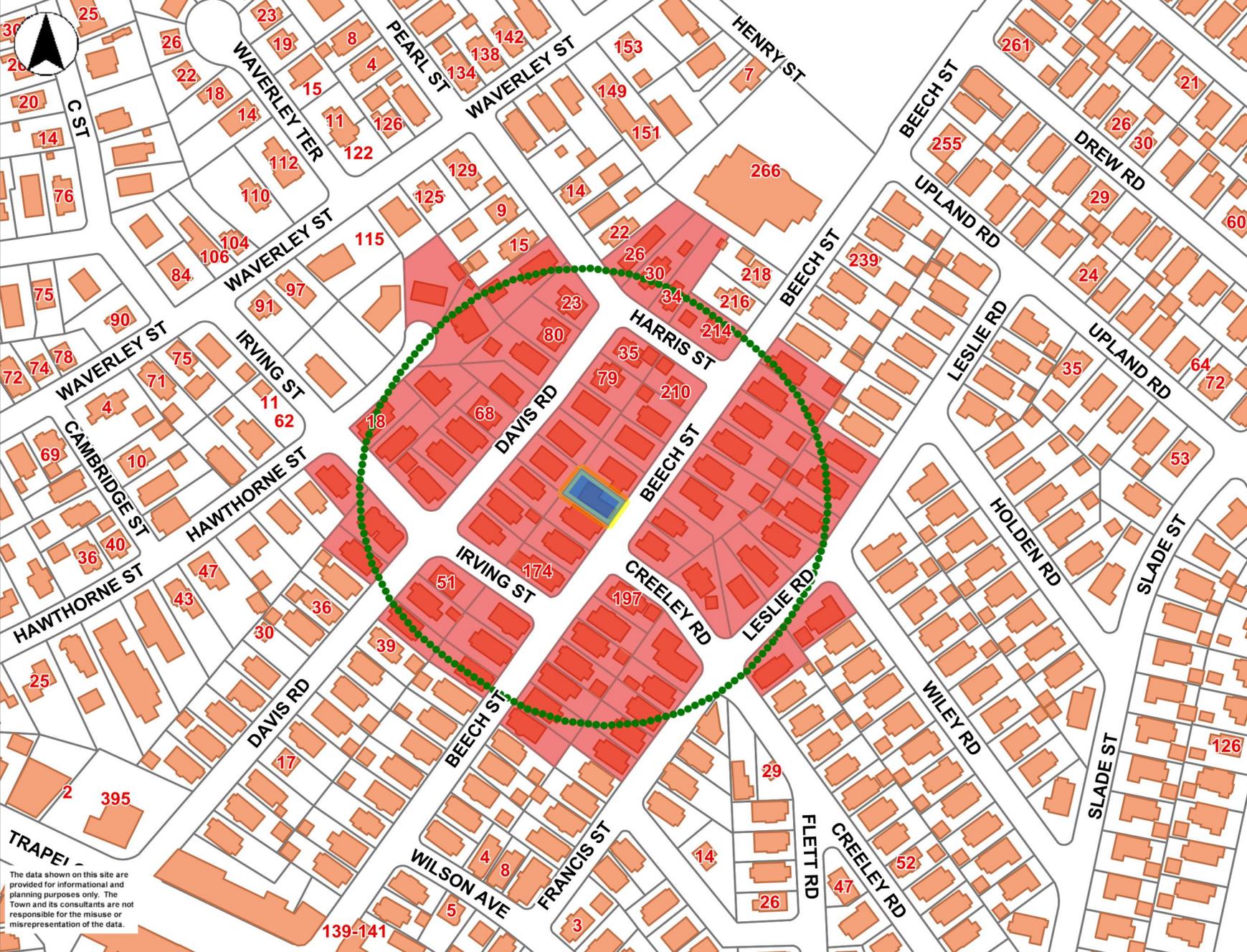

| 8. Allow for weather conditions and unforeseen delays | 3 weeks |

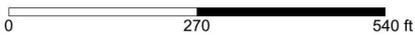
